- Gives the best possible first impression by greeting all passengers with a warm, sincere, and friendly welcome.
- Assists each passenger in and out of the van, ensure that they are secured safely in their seat or wheelchair, and help them in/out of their home/destination.
- Drives the van in a manner that complies with all local, state, and federal laws.

Ensures that the van is operating correctly at all times.

- Maintains complete and accurate daily records on the van's activity, passengers, and mileage.
- Cleans and refuels vehicle as needed and reports the need for servicing, lubricants, tires and accessories.
- Completes daily and weekly safety inspections of the vehicle.
- Stores vehicle appropriately and securely during and at the end of shift.

Ensures that all required paperwork is completed timely.

- Maintains complete and accurate daily records on the van's activity, passengers, and mileage.
- Submits all money receipts/work orders collected at the end of the day to the business office.

Provides nursing assistance as needed

- May need to assist resident with toileting while on transportation
- May be requested to sit in with appointment as needed based upon resident needs.
